Hours: 8:00 a.m. to 4:00 p.m. MONDAY-FRIDAY **Closed 1:00 p.m. to 2:00 p.m.**
- ACCEPTABLE FORMS OF PAYMENTS ARE CASH, MONEY ORDERS, CERTIFIED CHECKS, BUSINESS CHECKS, AND PAYROLL DEDUCTIONS. **PERSONAL CHECKS ARE NOT ACCEPTED.**
- PLEASE HAVE YOUR DOCKET NUMBERS READY FOR THE PAYMENT CLERK. BEGINNING JANUARY 1, 2022, A FEE OF \$1.00 WILL BE CHARGED IF YOU DO NOT HAVE YOUR DOCKET NUMBERS FOR THE PAYMENT CLERK.
- ALL COINS MUST BE IN WRAPPERS AND CANNOT EXCEED \$10.00. ALL BILLS ARE TO BE IN THE LARGEST DENOMINATION POSSIBLE.

- **YOUR NAME, RETURN ADDRESS, AND DOCKET NUMBER MUST BE ON THE MONEY ORDER OR CERTIFIED CHECK.**
- **ALL CERTIFIED CHECKS AND MONEY ORDERS MUST BE MADE PAYABLE TO FINES AND COSTS.**

2. PAYMENTS FOR CLIENTS IN **STATE CORRECTIONAL INSTITUTIONS.**
3. PAYMENTS OWED FOR **PROTECTION FROM ABUSE (PFA) ACTIONS** (PAYMENTS FOR PFA MATTERS SHOULD BE MADE AT THE DAUPHIN COUNTY PROTHONOTARY'S OFFICE, 101 MARKET STREET, 1<sup>ST</sup> FLOOR, HARRISBURG, PA)
